The abstract must include **5–6** keywords.

Submissions should be in **MS Word format (.doc/.docx)**.

References:

Must be properly cited and included in the manuscript.

All submissions must strictly follow the **APA 7th Edition** citation style.

Plagiarism Policy:

Authors must submit a plagiarism report along with the full paper.

A maximum of **10% similarity is permissible** (excluding references and properly cited quotations).

Participants must **complete registration & submit Abstract** on or before **10th August 2026**.

Submissions must be original, unpublished, and not under consideration elsewhere.

Authors are encouraged to submit the full paper after the seminar, incorporating feedback received during presentation.

Presentation & Publication:

Only authors of accepted abstracts will be permitted to present at the seminar.

Only papers presented during the seminar will be considered for publication, subject to peer review.
